Customers of self-funded clients pay a dispensing fee for these medications not to exceed \$12 per prescription. ▪ Additional Details: Customers receive a quantity limit of one course of therapy per 120 days. ▪ In and out of network coverage applies 	<ul style="list-style-type: none"> ▪ Cigna Pharmacy complied with government mandated process and cost during FDA EUA during PHE. Once government funded program ends, customer \$0 will end. After that, FDA-approved antiviral and therapeutics will be covered with the cost share subject to plan design. ▪ In network coverage applies
COVID Vaccines	<ul style="list-style-type: none"> ▪ Cigna Pharmacy clients and customers pay \$0 ingredient cost while funded by the government during the EUA period. Customer responsibility is \$0 unless otherwise stated to be a different amount by state regulation. ▪ In and out of network coverage applies 	<ul style="list-style-type: none"> ▪ Customers pay \$0 under Patient Protection and Affordable Care Act (PPACA). Customers whose plans are grandfathered, and have advised that they don't have PPACA Coverage will follow standard vaccine cost share. Coverage is for in-network only unless benefit coverage or state regulations require otherwise ▪ Additional Details: Cigna Pharmacy clients will be responsible for the cost of the vaccines per standard contracts.
